

#### Models of sustainable development have changed over time



































# Introduction to the Wellbeing and Sustainable Development Bill

- The Scottish Government recognises the duty to protect the interests of future generations. We also recognise that our ability to have a thriving society and economy is derived from the health of the planet.
- Continually improving the National Outcomes is one of the ways we can achieve these aims and ensure that we are able to deliver long-term and sustainable policy and delivery approaches. To do this, we need responses from people and organisations across Scotland.





#### Why this is needed

 Recent engagement activity reviewing the National Performance Framework highlighted a perceived 'implementation gap' between the stated aims of the framework and its delivery.

Top 10 themes identified as impacting 'Implementation' in the Review of the National Outcomes

- 1. Policy
- 2. Delivery
- 3. Accountability
- 4. Funding
- 5. Collaboration
- 6. Awareness
- 7. Tools and guidance
- 8. Alignment
- 9. Legislation
- 10. Budget





#### Early Development of the WSD Bill:

- WSD Bill development to date has been informed by:
- FPAC inquiries into the NPF and effective decision making.
- NPF Review and discussion with other areas of SG.
- Sarah Boyack MSP WSD Member's Bill consultation.
- Engagement with the Third Sector
- Engagement with governments both in the UK and internationally who have successfully implemented similar measures.
